If you are to be found that you have been charged and falsify this application saying that you have not been charged or had animal control out to your property that your Kennel License will be revoked and you will not be able to receive a Kennel License in Breckinridge County again. Failure to permit an ACO to inspect kennels regulated by this Ordinance during reasonable hours shall be grounds for Kennel License revocation. License revocation shall be in writing and shall state the grounds therefore. Any person whose Kennel License is revoked may appeal such revocation to Breckinridge County Fiscal Court within 30 days following the date of revocation. Said appeal shall be in writing and shall state the grounds therefore, and shall be signed by the person appealing and signed by the person bringing in the appeal. If requested by the appellant, a hearing shall be held on the issues raised by the appeal. The hearing shall be held before the Breckinridge County Fiscal Court.
